## MIDWEST HIGHLIGHTS

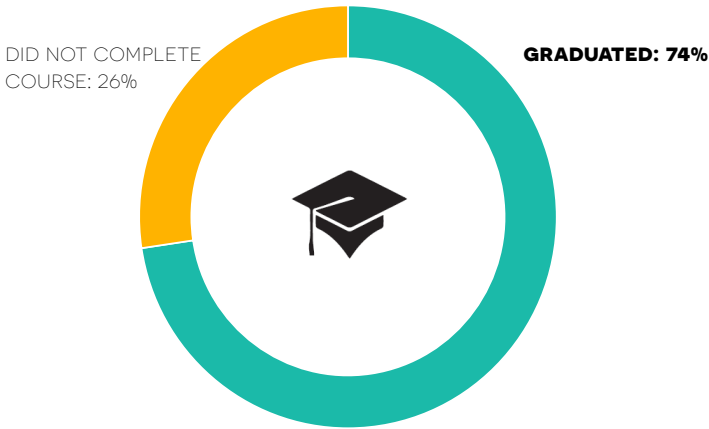
Building Operator Certification experienced another successful year in 2022 thanks to our incredible partners, expert instructors and coordinators, and dedicated staff.

### GRADUATION RATE

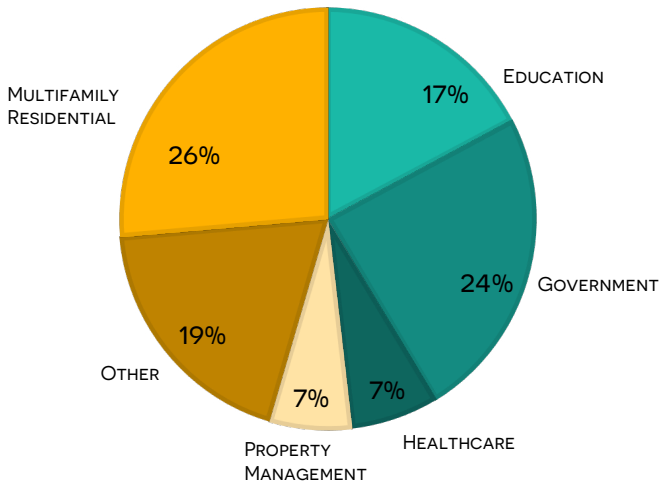


### 2022 Highlight: Student Metrics

We hosted 11 full courses: eight Level I, one Level II, and two Multi-family Pilots. These courses gathered a total of 220 students across nine Midwest states. 74% of these students completed the course and received a Training Certificate of Completion (TCOC). We saw the most students coming from the multi-family residential, education and government sectors.

As our new student list grew, we continued to offer Continuing Education Unit (CEU) opportunities for our graduates. We offered multiple two-day (six hours total) courses that pulled directly from the BOC curriculum and were taught by our own BOC instructors. We also hosted several one-hour webinars that focused on topics ranging from new energy efficiency technology to indoor air quality and safety, which were taught by various partners. ### 2022 Highlight: BOC Level I Multifamily Pilots

In 2022, MEEA invested in the development of a new curriculum, BOC Level I Multifamily, that builds off the existing BOC Level I curriculum with a focus on equipment and challenges commonly encountered in multifamily buildings. We hosted two pilot courses during 2022, one online and one in-person in Okemos, MI, that together trained 60 students. The extensive feedback collected from the students, instructors and coordinators during these pilot classes, plus another pilot hosted by a different BOC administrator, will inform final modifications to the curriculum. # 2022 YEAR IN REVIEW

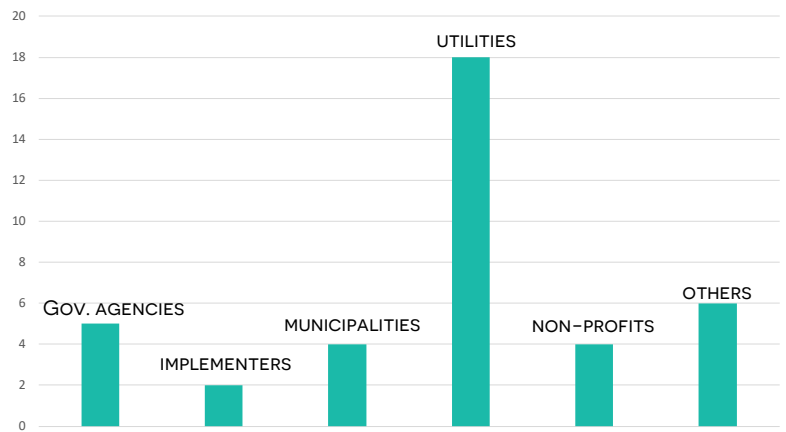
## Partner Highlights:

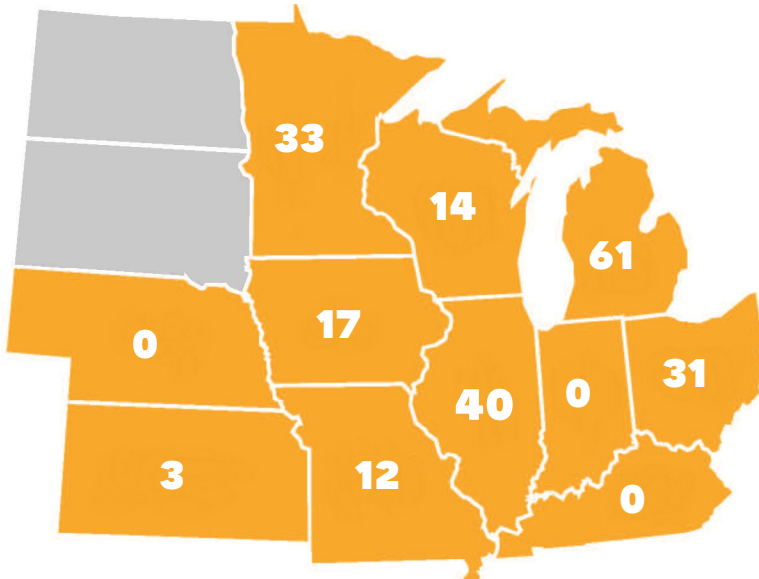
## A few state highlights:

- Illinois: In partnership with Ameren, ComEd, Nicor Gas, Peoples Gas and North Shore Gas, we hosted two courses specifically for students in Illinois, including one in-person course hosted in Chicago.
- Michigan: Our first in-person Multifamily course was hosted in Okemos, MI and was sponsored by Consumers Energy. Additionally, our 2022 CEU courses were hosted thanks to help from our Michigan utility partners. Our two-day courses were sponsored by Consumers Energy & DTE Energy and the one-hour webinars were sponsored by Consumers Energy.
- Iowa: The Energy Association of Iowa Schools piloted a Building Operator Pathway (BOP) course for high schoolers interested in careers in building operations.
